EXHIBITION

Each selected artist must transfer the exhibition organization fee to the account of Atelier-Galerie Herwig Maria Stark within 7 days of receiving written confirmation and invoicing.

The pro-rata exhibition and organization costs cover the expenses for the organization and logistics of the exhibition and the included PR -package.

TERMS OF PAYMENT

The participation fee is € 250,- including 20% VAT and the PR package.

The pro-rata exhibition costs must be paid exclusively in euros. All bank charges are to be borne by the exhibiting artist.

APPLICATION

The application must contain the following documents:

- Artist Statement, short text (max. 300 words) and a brief concept (max. 300 words) explaining how your work relates to the theme, as well as a short CV
- An image file of 4-5 artworks you want to exhibit. Submit images as JPEGs (900 pixels longest side, 72 dpi) or PDFs without watermarks or signatures.
- All participating artworks must be available for sale. The artist must set the sales price.
- The complete filled and signed data sheet of the artworks
- The complete filled and signed Application form
- A copy of your payment document for the application fee

Only complete applications will be considered by the selection committee.

The application does not include automatically participating in the respective exhibition.

SALES

All exhibits must be available for sale, with the selling price determined by the artist. Taxes, customs duties and fees are to be included in the selling price.

Atelier – Galerie Herwig Maria Stark charges NO sales commission. 100% of the sales proceeds go to the exhibiting artist.

Artists from EU countries are required to provide their VAT number. Artists from outside the EU must inform themselves about the tax obligations that arise from participating in the exhibition.

By signing the registration form, you confirm that Atelier-Galerie Herwig Maria Stark is exempt from all claims relating to the exhibiting artist's obligation to pay tax or customs duties.

ADVERTISING / COPYRIGHT

Atelier-Galerie Herwig Maria Stark is entitled to have photographs or film recordings made of the exhibition, the exhibition setup and the exhibits, and to use these for advertising and press publications relating to this or other exhibitions organized by Atelier-Galerie Herwig Maria Stark. This includes all publications, printed matter and advertisements in print or electronic media. The copyright and all other rights remain with the exhibiting artist.

INSURANCE AND LIABILITY:

The exhibiting artist/ artists' association is responsible for ensuring their works or exhibits them at their own risk.

No liability is accepted for personal injury or property damage caused by natural disasters, theft or vandalism during set-up and/or dismantling and during the exhibition. The exhibiting artist or artists' association waives all claims of any kind against the Atelier-Galerie Herwig Maria Stark, its employees or temporary staff (of any gender).

FORCE MAJEURE

- If the exhibition must be canceled or postponed to another date, it may be what reason and in what sphere of respective circumstance whatsoever located, the exhibiting artist cannot derive any claim for damages.
- The exhibiting artist is not entitled in exceptional circumstances, as in all cases of force majeure to rescission, refund or reduction of the exhibition fee.

TRANSPORT

The artist is responsible for organizing and paying for the transport to and from the Atelier-Galerie Herwig Maria Stark, Kohlgasse 51 top 2, A-1050 Vienna, Austria.

Transport is at the artist's own risk. If special import or export documents are required for the exhibition, the exhibiting artist must commission a freight forwarder to handle this.

The artist is responsible for ensuring that the works are properly packaged. Any special packaging requirements must be indicated in advance. Atelier-Galerie Herwig Maria Stark accepts no liability for damage resulting from incorrect or improper packaging or missing instructions.

All exhibition pieces must be delivered ready to hang. The exhibits must be labelled on the back (in block letters) with the name of the artist, nationality, title of the work, year of creation, dimensions and technique. In addition, a signed 'Certificate of Origin' must be included with each exhibit upon delivery.

DELAYED DELIVERY AND RETURNS

Atelier – Galerie Herwig Maria Stark reserves the right to reject an exhibit if it is delivered late, is damaged upon delivery, appears unstable during exhibition setup, or differs significantly from the image submitted digitally.

Return costs shall be borne solely by the artist.

RETURN CONSIGNMENT

At the end of the exhibition the artworks will be packaged in the same packaging material in which they arrived (if the artist is located outside of Vienna or Austria). The transport from the exhibition space must be organized by the artist himself.
Detailed advice (pick up date) will be communicated after selection.

GENERAL

This agreement is binding and cannot be unilaterally amended or repealed by the exhibiting artist. A change or alteration of the agreement, even partial or annulling the agreement by one of the contracting parties requires a written form.

By signing the application form and after jury selection for participation in the exhibition, the exhibiting artist accepts for himself and his agents the terms of conditions of Atelier-Galerie Herwig Maria Stark as an organizer and operator of the respective exhibition as binding and moreover also binds himself to comply with the rules of Atelier-Galerie Herwig Maria Stark in all parts.

RESERVATIONS of Atelier-Galerie Herwig Maria Stark:

If the exhibition must be postponed to another date for an important reason, the exhibiting artist or artists' association cannot derive any claim for damages from this. If the organizers cancel the exhibition for an important reason, the artist or artists' association will be refunded the fees they have paid. There is no entitlement to participation, compensation or alleged damages.

FINAL CONDITIONS:

Only written agreements between the exhibiting artist/artists' association and the Atelier-Galerie Herwig Maria Stark are valid. The place of performance and jurisdiction for all mutual obligations is Vienna. Austrian law applies.
